### **Payment**

- Once we have received your completed booking form we will issue an invoice for the amount due. The booking is **not confirmed until we have received payment**
- If paying by **cash**, please include room hire and deposit with enclosed completed booking form
- If paying by **cheque**, please provide 2 cheques. A cheque for hall hire and a cheque for the deposit. The deposit cheque is the holding cheque for any damages / breakages that may have happened when holding your event. **Cheques payable to 'Myddle Village Hall'** with enclosed completed booking form.
- If paying by **BACS** transfer the payment must be made as soon as you receive confirmation of acceptance of the booking from the Booking Secretary who will give you the booking reference number to use as the reference number for the payment. # Myddle Village Hall

## Standard Conditions of Hire

These standard conditions apply to all hiring of the Village Hall.

1. Applications for the use of any of the facilities at Myddle Village Hall, shall be made, on a booking form, and returned to the Booking Secretary. Please note that until this form has been returned, and any necessary deposit paid, no engagement will be booked.
2. Appointments may be made directly with the Booking Secretary should the Hirer wish to view the facilities available prior to making a booking. The person whose name is stated on the Booking Form must be over the age of 21 years of age and will be deemed to be the Hirer.

### Licence

3. The Village Hall has a **Premises Licence** authorising the performance of plays, the showing of films, indoor sporting events, live music, recorded music and dancing between 8.00AM and Midnight on Sunday through to Thursday and between 8.00AM and 1.00AM on Friday and Saturday.
4. The Hirer will need to advise the Booking Secretary in order for a bar to be provided by or arranged with the Village Hall's Designated Premises Supervisor. Any Hirer wishing to use a Temporary Event Notice (TEN) instead of a bar arranged with the Designated Premises Supervisor must seek permission from the Booking Secretary prior to applying to the local council for a TEN.
5. The maximum permitted number of people in the hall is 100 including organisers/performers. The Hirer agrees not to exceed this maximum.
6. Where a licensable activity will take place, the Hirer hereby acknowledges the event will comply with times listed above. The hall does have a license with the Performing Right Society for the performance of copyright music.
7. The Hirer agrees with the Village Hall to be present (or represented by an authorised representative, if appropriate) during the hiring and to **comply fully with this Hire Agreement**.
8. It is hereby agreed that the Standard Conditions of Hire together with any additional conditions imposed under the Premises License or that the Village Hall Management Committee deem necessary shall form part of the terms of this Hiring Agreement unless specifically excluded by agreement in writing between the Village Hall and the Hirer.
9. None of the provisions of this Agreement are intended to or will operate to confer any benefit pursuant to the Contracts (Rights of Third Parties) Act 1999 on a person who is not named as a party to this Agreement.

### Payment

10. Payment in full will be required to confirm a booking for a single occasion.
11. For bookings for multiple occasions payment in full for the first occasion will be required to confirm the booking.
12. For all types of booking a **refundable £50** damage deposit will also be required to be paid with the hire charge before the booking is confirmed. This damage deposit will be refunded for a booking for a single occasion within 14 days of the event date if the hall is deemed to have been left in a satisfactory condition. For bookings for multiple occasions the deposit will be returned within 14 days of the date of the second occasion if the hall is deemed to have been left in a satisfactory condition and payment for the first two occasions has been received.

13. By returning the requested payment and/or sending written confirmation, the Hirer is accepting all terms and conditions herein.

#### **Age**

14. The Hirer, being a person over 21 years of age, hereby accepts responsibility for overseeing the premises during the period of hire and for ensuring that all conditions, under this Agreement, relating to management and supervision of the premises are met.

#### **Supervision**

15. The Hirer shall, during the period of the hiring, be responsible for:
  - a. supervision of the premises, the fabric and the contents;
  - b. their care, safety from damage however slight or change of any sort;
  - c. and the behaviour of all persons using the premises whatever their capacity, including proper supervision of car parking arrangements to avoid obstruction of the highway.
16. As directed by the management committee, the Hirer shall make good or pay for all damage (including accidental damage) to the premises or to the fixtures, fittings or contents and for loss of contents.

#### **Use of premises**

17. The Hirer shall not use the premises for any purpose other than that described in the Hiring Agreement and shall not sub-hire or use the premises or allow the premises to be used for any unlawful purpose or in any unlawful way nor do anything or bring onto the premises anything which may endanger the same or render invalid any insurance policies in respect thereof nor allow the consumption of alcohol thereon without written permission. The management committee shall have the right to refuse admission to any person whom they consider undesirable and shall not be bound to give a reason for so doing.

#### **Gaming, betting and lotteries**

18. The Hirer shall ensure that nothing is done on or in relation to the premises in contravention of the law relating to gaming, betting and lotteries.

#### **Licensable activities**

19. The Village Hall holds a **Performing Right Society License** which permits the use of copyright music in any form, e.g. record, compact disc, tapes, radio, digital recording, television or by performers in person. If other licenses are required in respect of any activity in the village hall the Hirer should ensure that they hold the relevant license or the village hall holds it.

#### **Health and hygiene**

20. The Hirer shall, if preparing, serving or selling food, observe all relevant food health and hygiene legislation and regulations. In particular dairy products, vegetables and meat on the premises must be refrigerated and stored in compliance with the Food Temperature Regulations. A refrigerator is provided on the premises.

#### **Animals**

21. The Hirer shall ensure that no animals (including birds) except assistance dogs are brought onto the premises, other than for a special event agreed to in advance by the management committee. No animals whatsoever are to enter the kitchen at any time.

#### **Public safety compliance**

22. The Hirer shall comply with all conditions and regulations made in respect of the premises by the Local Authority, the Licensing Authority, the Village Hall's Fire Risk Assessment or

otherwise, particularly in connection with any event which constitutes regulated entertainment, at which alcohol is sold or provided or which is attended by children. The Hirer shall also comply with the Village Hall's Health and Safety policy.

23. The Hirer acknowledges that they have received instruction in the following matters:
  - a. The action to be taken in event of fire - this includes calling the Fire Brigade and evacuating the hall.
  - b. The location and use of fire equipment
  - c. Escape routes and the need to keep them clear.
  - d. Method of operation of escape door fastenings.
  - e. Appreciation of the importance of any fire doors and of closing all fire doors at the time of a fire.
24. In advance of an entertainment or play the Hirer shall check the following items:
  - a. That all fire exits are unlocked and panic bolts in good working order.
  - b. That all escape routes are free of obstruction and can be safely used.
  - c. That any fire doors are not wedged open.
  - d. That exit signs are illuminated.
  - e. That there are no obvious fire hazards on the premises.

#### **Outbreaks of fire**

25. The Fire Brigade shall be called to any outbreak of fire, however slight, and details thereof shall be given to the Caretaker.

#### **Electrical appliance safety**

26. The Hirer should be aware of the following:
  - a. The Hirer shall ensure that any electrical appliances brought by them to the premises and used there shall be safe, in good working order, and used in a safe manner in accordance with the Electricity at Work Regulations 1989. Where a residual circuit breaker is provided the Hirer must make use of it in the interests of public safety.
  - b. The Village Hall does not accept any responsibility should any such appliance activate the systems that protect the hall's power supply.
  - c. The Village Hall will not accept any responsibility for any inconvenience or loss, including consequential loss, that may occur due to a power failure or by the power company supplying the hall in the form of a general 'power cut'.

#### **Insurance and indemnity**

27. The Hirer shall be liable for:
  - a. The cost of repair of any damage (including accidental and malicious damage) done to any part of the premises including the curtilage thereof or the contents of the premises
  - b. All claims, losses, damages and costs made against or incurred by the Village Hall management committee, their employees, volunteers, agents or invitees in respect of damage or loss of property or injury to persons arising as a result of the use of the premises (including the storage of equipment) by the Hirer, and
  - c. All claims, losses, damages and costs made against or incurred by the Village Hall management committee, their employees, volunteers, agents or invitees as a result of any nuisance caused to a third party as a result of the use of the premises by the Hirer, the Hirer shall indemnify and keep indemnified accordingly each member of the village hall management committee and the Village Hall's employees, volunteers, agents and invitees against such liabilities.

#### **Accidents and dangerous occurrences**

28. The Hirer must report all accidents involving injury to the public to the management committee as soon as possible and complete the relevant section in the Village Hall's accident book. Any failure of equipment belonging to the Village Hall or brought in by the Hirer must also be reported as soon as possible. Certain types of accident or injury must be

reported on a special form to the Incident Contact Centre. A representative of the management committee will give assistance in completing this form. This is in accordance with the Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 1995 (RIDDOR).

### **Smoking**

29. The Hirer shall ensure that all persons coming to the hall in connection with the hiring comply with the prohibition of smoking in public places provisions of the Health Act 2006 and regulations made thereunder. Any person who breaches this provision shall be asked to leave the premises.

### **Explosives and flammable substances**

30. The Hirer shall ensure that:
- a. Highly flammable substances are not brought into, or used in any part of the premises, and that
  - b. No internal decorations of a combustible nature (e.g. polystyrene, cotton wool) shall be erected without the consent of the management committee. No decorations are to be put up near light fittings or heaters.
  - c. No naked lights are permitted.

### **Heating**

31. The Hirer shall ensure that no unauthorised heating appliances shall be used on the premises when open to the public without the consent of the management committee. Portable Liquefied Propane Gas (LPG) heating appliances shall not be used.

### **Sale of Alcohol**

32. The Village Hall licence prohibits the sale, or consumption, of alcohol to or by persons under 18. If the Bar Staff are in any doubt proof of age will be requested. Our bar staff have been asked to check proof of age for anyone who appears to be under 25 years of age.
33. The bar staff can refuse to serve unruly persons.
34. In the event of persistent non-compliance or unruly behaviour the bar staff will close the bar and cease the sale and consumption of alcohol.
35. No persons are allowed behind the bar without permission.
36. Unless specifically arranged in advance all alcoholic drinks must be supplied by Village Hall Bar.
37. Every sale or supply of alcohol must be authorised by the Village Hall DPS (Designated Premises Supervisor).
38. No alcohol to be consumed outside of the building.
39. Licensing hours will be confirmed by the Booking Secretary during the booking and form part of this agreement.
40. Outside doors and windows are to be kept closed to prevent a noise nuisance to nearby residents.
41. No glasses are to be taken out of the building.
42. It is the responsibility of the Hirer to ensure their guests leave the premises, car park and driveway quietly.
43. The management committee may, at its sole discretion, insist on professional Door Stewards attending an event, at the Hirer's expense.

### **Drunk and disorderly behaviour and supply of illegal drugs**

44. The Hirer shall ensure that in order to avoid disturbing neighbours to the hall and avoid violent or criminal behaviour; care shall be taken to avoid excessive consumption of alcohol. Drunk and disorderly behaviour shall not be permitted either on the premises or in its immediate vicinity. Alcohol shall not be served to any person suspected of being drunk nor to any person suspected of being under the age of 18. Any person suspected of being drunk, under the influence of drugs or who is behaving in a violent or disorderly way shall be asked to leave the premises. No illegal drugs may be brought onto the premises.

### **Fly posting**

45. The Hirer shall not carry out or permit fly posting or any other form of unauthorised advertisements for any event taking place at the premises, and shall indemnify and keep indemnified each member of the Village Hall's management committee accordingly against all actions, claims and proceedings arising from any breach of this condition. Failure to observe this condition may lead to prosecution by the local authority.

### **Sale of goods**

46. The Hirer shall, if selling goods on the premises, comply with Fair Trading Laws and any code of practice used in connection with such sales.

### **Noise**

47. The Hirer shall ensure that the minimum of noise is made on arrival and departure, particularly late at night and early in the morning.

### **No rights**

48. The Hiring Agreement constitutes permission only to use the premises and confers no tenancy or other right of occupation on the Hirer.

### **Dangerous and unsuitable performances**

49. Performances involving danger to the public or of a sexually explicit nature shall not be given.

### **Cancellation**

50. If the Hirer cancels the booking prior to the event taking place then the deposit will be refunded in full together with the percentage of the hire charge set out below:
- a. Less than **8 days** prior to the date of the booking 0%
  - b. Less than **31 days** but more than **7 days** prior to the date of the booking 50%
  - c. More than **30 days** prior to the date of the booking 100%
51. The management committee reserves the right to cancel this hiring by written notice to the Hirer in the event of:
- a. The premises being required for use as a Polling Station for a Parliamentary or Local Government election or by-election
  - b. The Village Hall reasonably considering that such hiring will lead to a breach of licensing conditions, if applicable, or other legal or statutory requirements, or
  - c. Unlawful or unsuitable activities will take place at the premises as a result of this hiring
  - d. The premises becoming unfit for the use intended by the Hirer
  - e. An emergency requiring use of the premises as a shelter for the victims of flooding, snowstorm, fire, explosion or those at risk of these or similar disasters.
52. In any such case the Hirer shall be entitled to a refund of any deposit already paid, but the Village Hall shall not be liable to the Hirer for any resulting direct or indirect loss or damages whatsoever.

### **End of hire**

53. The Hirer shall be responsible for leaving the premises and surrounding area in a clean and tidy condition, properly locked and secured unless directed otherwise and any contents temporarily removed from their usual positions (i.e., chairs and tables) properly replaced, otherwise the Village Hall shall be at liberty to make an additional charge. The Caretaker has instructions to close the hall 30 minutes after the end of the booking time. It is the responsibility of the Hirer to ensure all persons including helpers, musicians, and bar staff, etc., vacate the hall by that time. Kitchen equipment must be thoroughly cleaned and replaced in the cupboards provided. All breakages or damages must be reported to the Caretaker as soon as possible.

### **Stored equipment**

54. The Village Hall accepts no responsibility for any stored equipment or other property brought on to or left at the premises, and all liability for loss or damage is hereby excluded. All equipment and other property (other than stored equipment) must be removed at the end of each hiring or fees will be charged for each day or part of a day at the hire fee per hiring until the same is removed.

55. The Village Hall may use its discretion in any of the following circumstances:

- a. Failure by the Hirer either to pay any charges in respect of stored equipment due and payable or to remove the same within 7 days after the agreed storage period has ended.
- b. Failure by the Hirer to dispose of any property brought on to the premises for the purposes of the hiring. This may result in the Village Hall disposing of any such items by sale or otherwise on such terms and conditions as it thinks fit, and charge the Hirer any costs incurred in storing and selling or otherwise disposing of the same.
